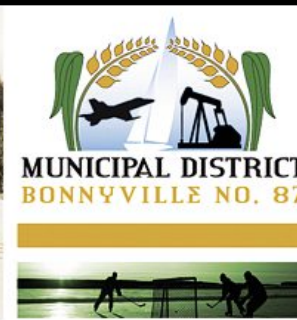

The Municipal District of Bonnyville is requesting proposals for gravel supplier(s) as per the following conditions:

1. Supply of Alberta Transportation Specified Designation aggregate of various size
2. Pricing is to be supplied from the pit or stockpile location and the location of the pile is to be supplied for haul evaluation. Multiple pit locations may be provided with a minimum of 30,000 tonnes each.
3. Quality control testing of 1 sieve analysis per daily crush volumes of product are to be supplied by the gravel supplier and performed by a certified materials testing lab. Material may be rejected if out of required specification.
4. All material to be available and completed by specified date.
5. Multi-year supply proposals accepted.

The Municipal District of Bonnyville will be evaluating all submissions and will determine the selected supplier(s) based on location and pricing.
