Take notice that the Council of the Municipal District of Bonnyville No. 87 is proposing to pass bylaws pursuant of Section 692 of the Municipal Government Act.

Bylaw No. LU 464 – To amend Bylaw No. 1207, being the Land Use Bylaw for rezoning SE 21-63-2-W4M, Plan 082 0072 Block 1 Lot 2 (144 acres more or less) from Agricultural (A) to Rural Industrial (RI) for Cold Lake Industrial Park located 1 mile west of the City of Cold Lake on Highway 55.

Bylaw No. LU 465 – To amend Bylaw No. 1239, being the Highway 55 Area Structure Plan to designate SE 21-63-2-W4M, Plan 082 0072 Block 1 Lot 2 (144 acres more or less) from Agricultural (A) to Rural Industrial (RI) for Cold Lake Industrial Park located 1 mile west of the City of Cold Lake on Highway 55.
