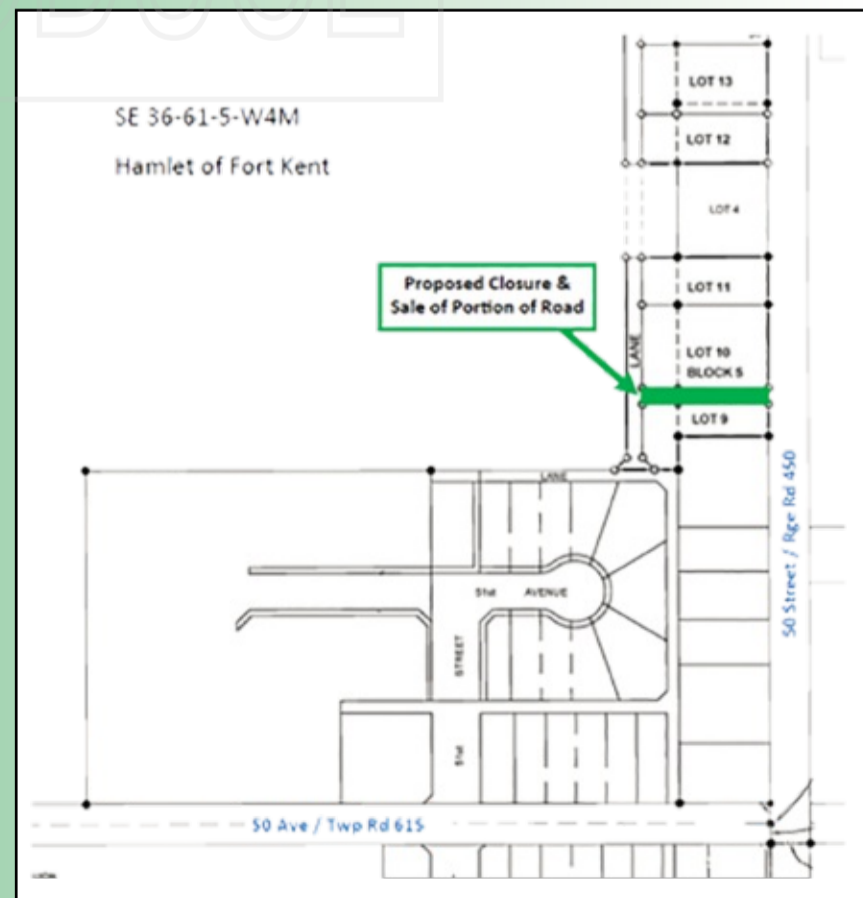
All that portion of lane north of Lot 9 Block 5 Plan 152 1454; Containing 0.037 hectares (0.09 acres) more or less
