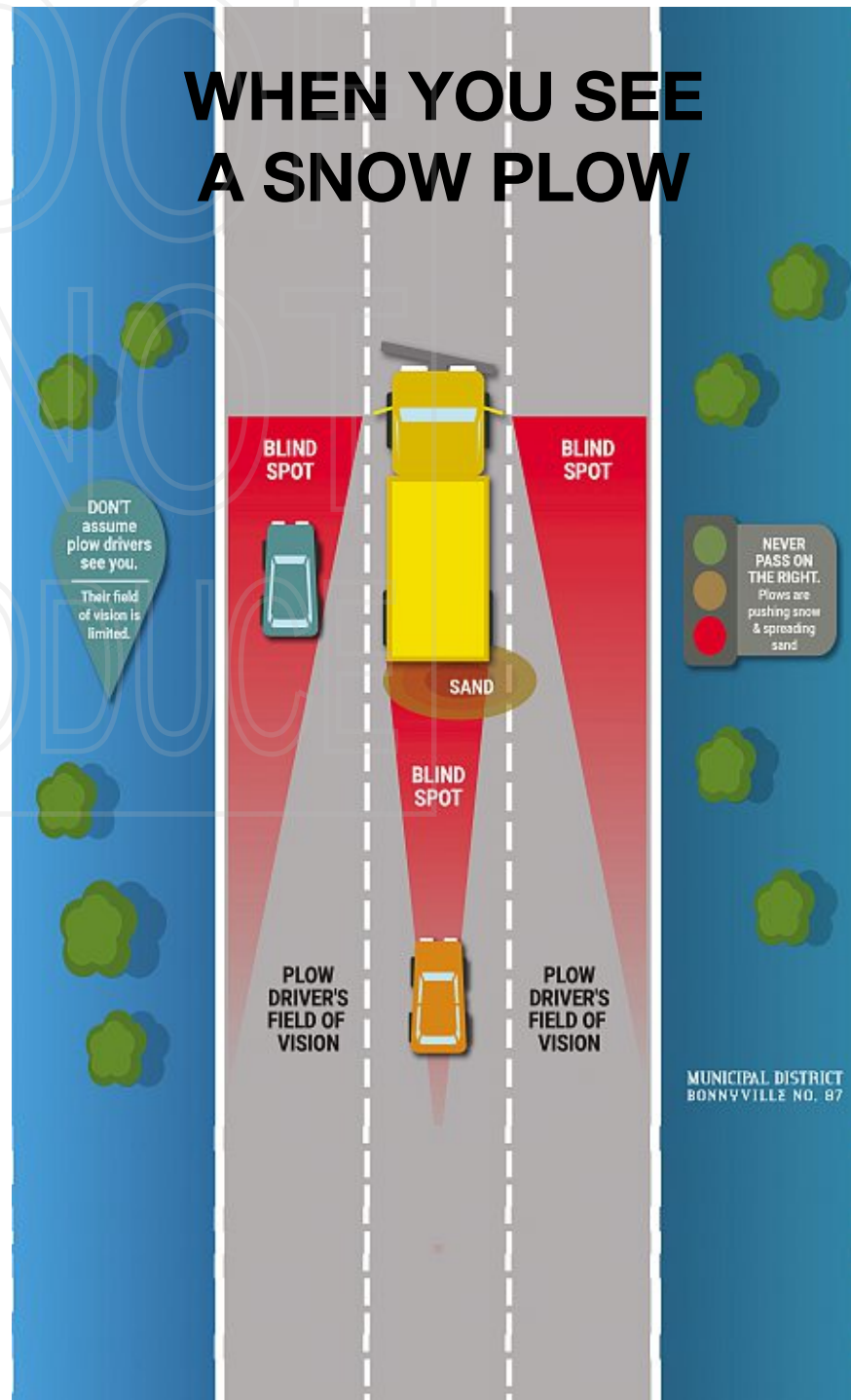
2021 Monthly Tax Payments Starting Soon
