BYLAW NO. 1441

A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87 IN THE PROVINCE OF ALBERTA TO AMEND THE BOUNDARIES OF WARD 2 AND WARD 3 AS ESTABLISHED BY BYLAW NO. 1310 OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87.

WHEREAS, Section 148(2) of the Municipal Government Act enables a council to pass a bylaw to divide the municipality into wards and establish their boundaries,

WHEREAS, it is deemed advisable to change the boundaries of Ward 2 and Ward 3 of the municipality to provide better representation for the communities in that area of the municipality.

NOW THEREFORE, the Council of the Municipal District of Bonnyville No. 87 duly assembled enacts the following:

- 1. Schedule "A" to Bylaw No. 1310 is hereby amended to change the boundaries of Wards 2 and Ward 3 of the municipality to the new boundaries set out in the attached Schedule "A".
- 2. This bylaw shall come into effect on the date of the October 2010 general election held in accordance with the Local Authorities Election Act.
- 3. The existing Councillors of the Municipal District of Bonnyville No. 87 at the time of the passing of this bylaw shall, unless otherwise disqualified, remain Councillors of the Municipal District of Bonnyville No. 87 until immediately before the beginning of the organizational meeting of the Municipal District of Bonnyville No. 87 held after the October 2010 general election.

The electoral boundaries for Ward 2 and Ward 3 of the Municipal District of Bonnyville No. 87 shall consist of all the following lands herein situated west of the Fourth Meridian and lying in the Province of Alberta excluding thereout all those areas contained within the boundaries of any City, Town, Village, Summer Village, Indian Reserve or Métis Settlement:

All of range 6; and

All that portion of range 7 lying north and east of the Bangs Lake, Kehewin Creek and Kehewin Lake:

Township 60

All of range 6; and

All that portion of range 7 EXCEPT that area lying:

- north and west of Thinlake River, and
- south and west of Bangs Lake.

Township 61

All of range 6.

Ward 3

Township 59

All that portion of range 7 lying south and west of Bangs Lake, Kehewin Creek and Kehewin Lake;

All of range 8: and

In range 9, the east halves of sections 1, 12, 13, 24, 25 and 36;

Township 60

All that portion of range 7 lying:

- north and west of the Thinlake River, and
- south and west of Bangs Lake;

All of range 8; and

In range 9, the east halves of sections 1, 12, 13, all of sections 21 to 28 inclusive, and all of sections 33 to 36 inclusive;

Township 61

All of ranges 7 and 8;

In range 9, all of sections 1 to 4 inclusive, the east halves of sections 5 and 8, all of sections 9 to 16 inclusive, the east halves of sections 17 and 20, all of sections 21 to 28 inclusive, the east halves of sections 29 and 32, and the all of sections 33 to 36 inclusive;

In range 10, the north half of section 1, the northeast quarter of section 2, the east half of section 11, all of sections 12 and 13, the east halves of sections 14 and 23, all of sections 24 and 25, the east halves of sections 26 and 35, and all of section 36;
